There is no fee to compete, and participants will be admitted to the event for free. **Audience tickets are \$1 each (limit of 10). Limit of 775 tickets.** Family and friends will have to purchase tickets to see the show. The show always sells out, so get your tickets early.

Teams from businesses, organizations, and groups will compete against each other in a family-friendly lip-sync contest. More than one team from each business or organization is encouraged. Winners and runners-up will receive cash prizes plus bragging rights among their peers.

We hope you will share your talent and join us for an entertaining evening on October 14th. Each team entered will be given three minutes to lip sync to the music of their choice. We ask that your music and skit be suitable for all ages as our audience includes a wide variety of people looking for a fun evening during Maple Leaf. No inappropriate language, dancing, etc. will be tolerated, and entire group will be disqualified.

We will have three age brackets: Youth (ages 2-8), Juniors (ages 9-17), and Adults (18 and older). Groups with participants in multiple age brackets will compete in the age bracket appropriate for the majority of their participants. Cash prizes will be given in each division! Performances will be judged on stage presentation, costumes, and lip sync ability.

# Maple Leaf Accident Waiver and Release of Liability Form

I certify that I am physically fit, have sufficiently prepared or trained for participation in the activity or event, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in this activity or event.

I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity or event in which I may participate, and that it will govern my actions and responsibilities at said activity or event. In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:
